#### **Deployment**

**Key elements about** the deployment of your vans:

You will receive an email from us with all the details about your vehicle delivery, including the list of VINs, the date, time, and other important information.

The vehicle model & type are **pre-determined by Amazon**, so we **will not be able to** offer different options.

You are likely to receive a refurbished van. The van has been refurbished to a standard that meets the agreed Fair, Wear and Tear standards (Appendix 1) and is ready to serve your needs.

#### **Jobs completion**

Preventive maintenance (PM)
Mandatory periodic inspection (MPI)
Ageing Fleet Found (AFF)

Actions to take <u>before</u> <u>peak</u> that will ensure vehicle availability:

For your benefit, ensure you complete all the mechanical repairs before peak. The AFF budget for 2024 **is not rolling into 2025**. Communication about it was shared in week 33.

To ensure vehicle availability during high demand period, we strongly recommend that you complete all the PM, MPI and recalls jobs due in 2024 **before 14 October.** This will help you avoiding issues such us your vehicle being ground by Amazon in case it becomes overdue.

You will have been contacted by Ayvens informing you which vehicles require PM and MPI to be booked in.

#### **Deflecting and FWT guidelines**

How to best maintain the van's conditions and prepare to defleet: Ensure you are carrying out daily walkaround checks and completing any reactive and scheduled maintenance.

Amazon provides us with the list of VINs for deflecting in advance. As soon as we receive it, we will share the details of the vans scheduled for collection with you.

As part of the handover process, make sure the vans are returned with same number of keys as when delivered, original vehicle paperwork and MOT certificates (ZB1 + TÜV).

The FWT guidelines (Appendix 01) will provide you a description of acceptable and unacceptable damages upon deflecting. They also outline the expected vehicle condition, including examples of acceptable damages that will not incur repairs or charges.
